Pre-Conference Workshops

Leveraging AI-Tools in Your Education Research
Presenters: Peter Boedeker and Grant Morgan

This training session introduces participants to practical AI applications that can streamline and enhance their research. The session will demonstrate 3–4 widely accessible tools for various elements of the research process. Participants will learn strategies for integrating AI ethically and effectively, while maintaining rigor and transparency. Hands-on activities will provide opportunities to explore how AI can support efficiency and broaden the impact of education scholarship.

Systematic Synthesis: Methods, Strategies, and Tools for a Rigorous Literature Review

Presenters: Shirley Matteson and Audrey Meador

In contrast to the purpose of a traditional literature review synthesis, a systematic synthesis seeks to provide an answer to a specific question through deep examination of published studies. There are numerous formats of such systematic reviews. This workshop will outline critical steps in undertaking and completing a systematic synthesis with an emphasis on those employing qualitative methods. Steps include determining a question, deciding what studies are relevant, deep reading of the content, determining how studies relate to each other, technology for managing the systematic review, synthesizing the information, and writing up the findings. Attendees will be guided through the features of a free, publicly available technology software for conducting a systematic literature synthesis. Attendees will collaborate with other workshop participants on a small-scale qualitative literature synthesis project, exploring data collection, extraction, evaluation, and analysis of existing literature on a topic. Future collaborations and continuation of the work discussed during the workshop is highly encouraged. Prior to the workshop, all participants who register for this training will be provided with information for requesting access to the technology and are encouraged to bring a device for access to the platform to engage in this work.

SERA Research Grants

Two research grants are available to SERA members.

The SERA Early Career Research Grant—Assistant Professor is available to those individuals who meet the following criteria:

- An assistant professor employed at a 4-year institution in a tenure-track position
- Attended and presented at SERA within the last three years
- Applicants are encouraged to collaborate with a mentor through the SERA Mentoring Initiative.

The SERA Early Career Research Grant—Doctoral Candidate is available to those individuals who meet the following criteria:

- A doctoral candidate who has defended a dissertation proposal approved by the dissertation committee.
- Attended and presented at SERA within the last three years.

Both SERA Research Grant awards provide up to \$1,000 for 1-year projects and may be awarded each year. Institutions may not charge indirect or overhead costs on these awards.

Funding restrictions

Previous award winners cannot reapply for the same award in subsequent years. SERA Board Members (either elected or appointed) are not eligible.

Evaluation criteria

The evaluation criteria will include: Quality of literature review, relevance of the topic, relevance of research questions, the strength of the methodology section, and quality of writing. An additional criterion will be whether or not the analytic methods fit the research questions.

Reporting requirements

All Research Grantees will be required to submit a SERA proposal through the Grants Coordinator, who will submit to SERA Program Chair for inclusion in a special session at the upcoming February Annual Conference. In order to receive the final grant funds (see funding

disbursement), an APA formatted manuscript must be submitted to the Grants Coordinator on or before the first day of the February Annual Conference for the subsequent year. See "Distributing Papers" in the SERA Call for Proposals.

Funding disbursement

Grantees will receive \$500.00 upon award selection and \$500.00 after presenting at the next February SERA Annual Conference (receipts must be submitted). Travel expenses to conferences may not exceed 30% of award total. The award amounts will not be channeled through institutions; thus, there are no overhead or indirect costs. It is expected that the award winners will be present at the SERA luncheon.

Application Deadlines

Applications for these Research Grants will be open once a year. Proposals must be submitted to the SERA Research Grant Coordinator, Chrissy Cross at crossc1@sfasu.edu and Shirley Matteson at shirley.matteson@ttu.edu.

SERA Linda Reichwein Zientek Outstanding Paper Award

Authors are encouraged to email copies of the paper submitted for presentation at the annual meeting to the SERA Executive Director, Forrest Lane. An individual may submit only one paper on which he/she is author or coauthor. The winner of the Outstanding Paper Award in the prior year is not eligible for consideration. Active officers of the SERA Executive Council, including appointed officers, are not eligible.

Award: \$1,000; present paper at AERA in 2027

Deadline: January 3, 2026 (12:00pm)

SERA Dean's Awards

Papers for consideration of the SERA Dean's Award must only be authored by graduate students. The award may be given to the first author only or to all authors. Completed graduate student research (Division I-V) and works in progress (Division VI) are eligible. Papers can be in any form (i.e., literature reviews, explanation of statistical concepts, case studies, other), and will be judged from the perspective of how well they will further the theory of educational research. Student recipients must be from a university that provides an award and must attend the 2026 SERA annual conference. More deans are expected to enroll soon. Students who are not enrolled in a university whose Dean of the College of Education supports this award are not eligible.

Awards: \$300 per university for two \$150 awards

SERA Outstanding Graduate Student Paper Award

The first author must be a graduate student. Papers must be completed graduate student research (Division I through Division V); may be a condensed version of a thesis or dissertation, as well as other research; and are presented as papers or symposiums at the conference. Works in progress (Division VI) and preliminary works, such as literature reviews, class projects, proposals, are not eligible for the award.

SERA Outstanding Undergraduate Student Paper Award

The Outstanding Undergraduate Student Paper Award competition is for completed undergraduate student research (i.e., ONLY Division I through V papers), and may include capstone projects, collaborative work with a faculty member, or other undergraduate student research. The award will be given for the best paper presented by an undergraduate student member at the annual meeting. For a paper to be eligible, the work must be completed before the annual meeting and then presented in a paper or symposium session.

2026 Presidential Invited Address



Jill Alexa Perry, Ph.D.

University of Pittsburgh

Professor of Practice and Director, Carnegie Project on the Education Doctorate

Dr. Jill Alexa Perry is the first full Professor of Practice in the School of Education at the University of Pittsburgh. Her research focuses on professional doctorate preparation in education, organizational change in higher education, and faculty leadership roles. Currently she is researching the ways EdD programs teach practitioners to utilize research evidence. She teaches and coaches how to teach Improvement Science in EdD programs. Her books include *The Improvement Science Dissertation in Practice*, *The EdD and the Scholarly Practitioner*, and *In Their Own Words: A Journey to the Stewardship of the Practice in Education*.

Dr. Perry is a graduate of the University of Maryland, where she received her PhD in International Education Policy. She holds an MA in Higher Education Administration and a BA in Spanish and International Studies from Boston College. She has over 25 years of experience in leadership and program development in education and teaching experience at the elementary, secondary, undergraduate, and graduate levels in the US and abroad. She is a Fulbright Scholar (Germany) and a returned Peace Corps Volunteer (Paraguay).



About the HARE Electoral System

SERA elections use the Hare system. This system reallocates votes in races with more than 2 candidates until each position obtains a majority of the votes cast. Sometimes this system is also called the "Instant Run-off Voting System." For example, if 3 candidates were running for one office, and the first-round rankings were:
